

**LEADING EDGE CREDIT UNION – SERVICE SATISFACTION SURVEY**  
**January 16 to February 10, 2017**  
**CONTEST TERMS AND CONDITIONS**

This Contest is open to **Leading Edge Credit Union** Survey participants and members only. Credit Union Employees, Directors and Spouses, as well as employees, of the sponsor(s) and its/their subsidiaries and affiliates are not eligible. Participants must be 19 years of age or older to claim the prize. Odds of winning depend on the number of eligible entries received.

Winner will be drawn by February 24, 2017 and will be contacted within a week. The winner's name will be published once the winner has been verified and prize claimed.

**Official Contest Rules**

1. **NO PURCHASE NECESSARY.** A purchase will not increase your chances of winning.
2. **ELIGIBILITY:** To be eligible for this Contest, an individual must: (i) be a member of *Leading Edge Credit Union*; (ii) be a legal resident of Newfoundland, Canada; (iii) have reached the age of majority in their province at the time of entry; and (iv) complete all questions on the survey.
3. **HOW TO ENTER:** The Contest begins January 16, 2017, and closes at 11:59pm on February 10, 2017. To enter the Contest, complete the online survey and include your contact details where indicated. The submission of the online entry form indicating contest entry constitutes an 'Entry'. There is a limit of one entry per person. Additional Entries by the same person will be disqualified. All Entries must be submitted no later than 11:59pm on February 10, 2017. All Entries become the property of Leading Edge Credit Union. Entries will only be accepted via completion of the online survey. Incomplete or late Entries will be disqualified. Unless indicated, no Entries will be accepted by any other means.

  - a. One winner will be drawn randomly from all eligible Entries received.
  - b. The draw will take place by February 24, 2017.
  - c. Chances of winning depend upon the number of eligible Entries received.
  - d. The selected entrants will be notified by phone or email on the date of the draw and must respond within five (5) business days.
